### Pipe Trades Services MN Pension Fund Notice of Internet Availability

The following document for the Pipe Trades Services MN Pension Fund (“**Pension Fund**”) is now available:

**Summary of Material Modifications (“SMM”).** An SMM is an important document that notifies Participants of changes to the Pension Fund and the information included in the Pension Fund’s Summary Plan Description (“**SPD**”). This SMM relates to an amendment reflecting a change in the law that limits the Pension Fund’s ability to recover inadvertent benefit overpayments from Participants, Beneficiaries and Alternate Payees as required by the SECURE 2.0 Act.

You can view the SMM by: (1) logging into the employee portal at [www.ptsmn.org](http://www.ptsmn.org), (2) clicking the header labeled “**MEMBERS+**,” (3) selecting “**Pension Fund**” from the dropdown menu, (4) click on the section labeled “**Plan Documents**” at the bottom of the Pension Fund page, (5) then select “**PTSMN Pension SMM (January 2026)**.” If you have not accessed your employee portal before, you can register at <https://www.ptsmn.org/register.php>.
